Get to Know Me

After more than 40 years of extensive surgical experience in all types of tumors in the [head and neck](#) — including mouth, throat, larynx, sinuses, skull base, thyroid, salivary glands, skin, soft tissues, and bone tumors — I now no longer perform surgery. However, I do provide consultations to patients to discuss treatment options, the pros and cons of various surgical approaches, as well as non-surgical treatments, and the expected outcomes in terms of tumor control and quality of life.

I will then provide recommendations and referrals to the most appropriate specialist for their specific problem. Such consultation permits the patient to make an informed decision regarding their treatment at MSK.

What I Do at MSK

I'm a head and neck surgeon, which is a doctor with special training in surgery on the head and neck. This includes the tonsils, tongue, mouth, lips, larynx, nose, sinuses, salivary glands, and thyroid gland.
