Get To Know Me

I am a radiologist with expertise in <u>breast imaging</u> and oncologic body <u>computed tomography (CT)</u> scans. Imaging procedures support our ability to make timely, accurate diagnoses and select the appropriate treatments for patients, based on the results. At Memorial Sloan Kettering Cancer Center (MSK), I interpret the full range of imaging modalities used in the screening and diagnosis of breast cancer, such as <u>mammograms</u> (including <u>digital breast tomosynthesis</u>, also known as "3-D mammography"), sonograms, and <u>magnetic resonance imaging (MRI)</u>.

As a breast imager, I also perform image-guided interventional procedures. These include <u>stereotactic biopsy</u>, <u>ultrasound-guided biopsy</u>, <u>madioactive seed placement</u>, and wire localization. Finally, in addition to my clinical focus on breast imaging, I interpret CT scans and radiographs of the body.
