I am a genitourinary medical oncologist who has special training in the treatment of [prostate cancer](#). I take the time to speak with each person about their diagnosis and risk profile. I also explain the benefits and side effects of both standard therapies and clinical trials. Based on their preferences, I work with them to develop a personal, long-term treatment plan.

I work with experts from many different teams, including urologists, radiation oncologists, and nuclear medicine physicians who provide surgical, radiation, and radioligand treatments. Radioligand therapy is a type of targeted treatment that delivers radiation directly to cancer cells.
