I am a board-certified internist and nephrologist with special expertise in diagnosing and treating the kidney diseases associated with cancer and its treatments. Doctors with this type of expertise (sometimes called "nephro-oncologists") provide care to patients who are experiencing:

- the deleterious effects of chemotherapy on the kidneys (nephrotoxicity)
- severely impaired renal function requiring dialysis, and who also need chemotherapy to treat their cancer
- renal diseases (nephropathies) associated with solid tumors and hematological malignancies
- any of the complex metabolic disturbances that cancer patients can develop that also affect the kidneys.
