# Patiromer

This information from UpToDate® Lexidrug™ explains what you need to know about this medication, including what it's used for, how to take it, its side effects, and when to call your healthcare provider.

### **What is this drug used for?**

- It is used to treat high potassium levels.

### **What do I need to tell my doctor BEFORE I take this drug?**

- If you are allergic to this drug; any part of this drug; or any other drugs, foods, or substances. Tell your doctor about the allergy and what signs you had.
- If you have any of these health problems: Bowel block, constipation, or problems having a bowel movement.

This is not a list of all drugs or health problems that interact

with this drug.

Tell your doctor and pharmacist about all of your drugs (prescription or OTC, natural products, vitamins) and health problems. You must check to make sure that it is safe for you to take this drug with all of your drugs and health problems. Do not start, stop, or change the dose of any drug without checking with your doctor.

### **What are some things I need to know or do while I take this drug?**

- Tell all of your health care providers that you take this drug. This includes your doctors, nurses, pharmacists, and dentists.
- Have blood work checked as you have been told by the doctor. Talk with the doctor.
- Follow the diet plan that your doctor told you about.
- This drug prevents many other drugs taken by mouth from getting into the body. If you take other drugs by mouth, talk with your doctor or pharmacist about whether you need to take them at least 3 hours before or 3 hours after this drug.
- If you are 65 or older, use this drug with care. You could have more side effects.
- Tell your doctor if you are pregnant, plan on getting

pregnant, or are breast-feeding. You will need to talk about the benefits and risks to you and the baby.

### **What are some side effects that I need to call my doctor about right away?**

**WARNING/CAUTION:** Even though it may be rare, some people may have very bad and sometimes deadly side effects when taking a drug. Tell your doctor or get medical help right away if you have any of the following signs or symptoms that may be related to a very bad side effect:

- Signs of an allergic reaction, like rash; hives; itching; red, swollen, blistered, or peeling skin with or without fever; wheezing; tightness in the chest or throat; trouble breathing, swallowing, or talking; unusual hoarseness; or swelling of the mouth, face, lips, tongue, or throat.
- Signs of low magnesium levels like mood changes, muscle pain or weakness, muscle cramps or spasms, seizures, shakiness, decreased appetite, severe upset stomach or throwing up, or an abnormal heartbeat.

### **What are some other side effects of this drug?**

All drugs may cause side effects. However, many people have no side effects or only have minor side effects. Call your doctor or get medical help if any of these side effects or any other side effects bother you or do not go away:

- Diarrhea or constipation.

These are not all of the side effects that may occur. If you have questions about side effects, call your doctor. Call your doctor for medical advice about side effects.

### **How is this drug best taken?**

Use this drug as ordered by your doctor. Read all information given to you. Follow all instructions closely.

- Take with or without food.
- Mix powder with water, other drinks, or soft food like applesauce, yogurt, or pudding. Measure  $\frac{1}{3}$  cup (80 mL) of liquid or soft food. Pour half into a glass, mix in the powder and stir. Add the rest of the liquid or soft food and stir well. The powder will not dissolve. The mixture will look cloudy. You can add more liquid or soft food if the mixture is too thick.
- If the dose is 4 grams or less, you may mix this drug with less liquid or soft food. You must use at least 3 tablespoons (45 mL) of liquid or soft food. If you have questions about how to mix this drug, talk with the

doctor.

- If you do not use water to mix this drug, be sure you know how much potassium may be in the liquid or soft food you use to mix it.
- Do not heat or microwave.
- Do not mix this drug in warm or hot drinks or food.
- Do not take dry powder.
- After mixing, take your dose right away. Do not store for future use.
- After taking your dose, rinse cup with more liquid or soft food and drink or eat. Repeat as needed to make sure the entire dose is taken.

### **What do I do if I miss a dose?**

- Take a missed dose as soon as you think about it.
- If it is close to the time for your next dose, skip the missed dose and go back to your normal time.
- Do not take 2 doses at the same time or extra doses.

### **How do I store and/or throw out this drug?**

- Store in a refrigerator. Do not freeze.
- You may also store this drug at room temperature. If stored at room temperature, throw away any part not used after 3 months.

- Protect from heat.
- Keep all drugs in a safe place. Keep all drugs out of the reach of children and pets.
- Throw away unused or expired drugs. Do not flush down a toilet or pour down a drain unless you are told to do so. Check with your pharmacist if you have questions about the best way to throw out drugs. There may be drug take-back programs in your area.

## **General drug facts**

- If your symptoms or health problems do not get better or if they become worse, call your doctor.
- Do not share your drugs with others and do not take anyone else's drugs.
- Some drugs may have another patient information leaflet. If you have any questions about this drug, please talk with your doctor, nurse, pharmacist, or other health care provider.

- If you think there has been an overdose, call your poison control center or get medical care right away. Be ready

to tell or show what was taken, how much, and when it happened.
