

Budesonide (Systemic)

This information from UpToDate® Lexidrug™ explains what you need to know about this medication, including what it's used for, how to take it, its side effects, and when to call your healthcare provider.

What is this drug used for?

- It is used to treat Crohn's disease.
- It is used to treat ulcerative colitis.
- It is used to treat eosinophilic esophagitis.
- It may be given to your child for other reasons. Talk with the doctor.

Delayed-release capsules (Tarpeyo):

- This drug is not approved for use in children. Talk with the doctor.
- If your child has been given this form of this drug, talk with the doctor for information about the benefits and risks. Talk with the doctor if you have questions or concerns about giving this drug to your child.

What do I need to tell the doctor BEFORE my child takes this drug?

- If your child is allergic to this drug; any part of this drug; or any other drugs, foods, or substances. Tell the doctor about the allergy and what signs your child had.
- If your child has liver disease.
- If your child has an infection. This includes bacterial, viral, and fungal infections; amoeba infection (like traveler's diarrhea); herpes infection of the eye; malaria infection in the brain; threadworm infestation; or any other infection.
- If your child is taking any drugs (prescription or OTC, natural products, vitamins) that must not be taken with this drug, like certain drugs that are used for HIV, infections, depression, and others. There are many drugs that must not be taken with this drug.

This is not a list of all drugs or health problems that interact with this drug.

Tell the doctor and pharmacist about all of your child's drugs (prescription or OTC, natural products, vitamins) and health problems. You must check to make sure that it is safe to give this drug with all of your child's other drugs and health problems. Do not start, stop, or change the dose of any drug your child takes without checking with the doctor.

What are some things I need to know or do while my child takes this drug?

All products:

- Tell all of your child's health care providers that your child is taking this drug. This includes your child's doctors, nurses, pharmacists, and dentists.
- Have your child's blood work checked as you have been told by the doctor. Your child may also need to have eye pressure and bone density checked if this drug is used for a long time.
- Do not give this drug to your child for longer than you were told by the

doctor.

- If your child has high blood sugar (diabetes), talk with the doctor. This drug can raise blood sugar.
- Check your child's blood sugar as you have been told by the doctor.
- Steroid drugs, including this one, raise the risk of infection. They can cause an active infection to get worse. They can also make some signs of infection harder to notice. Infections that happen with steroids can be mild, but they can also be severe and even deadly. The risk of problems from these infections is usually raised with higher doses of steroids. Have your child wash hands often and stay away from people with infections, colds, or flu. Tell the doctor if your child has any signs of an infection.
- Some infections may become active again in patients taking drugs like this one. This includes tuberculosis and hepatitis B. Tell the doctor if your child has ever had one of these infections.
- Chickenpox and measles can be very bad or even deadly in some people taking steroid drugs like this drug. Avoid having your child near anyone with chickenpox or measles if your child has not had these health problems before. If your child has been exposed to chickenpox or measles, talk with the doctor.
- This drug may lower how much natural steroid is in your child's body. If your child has a fever, an infection, surgery, or is hurt, talk with the doctor. Your child may need extra doses of oral steroids. These extra steroids will help your child's body deal with these stresses. Carry a warning card saying that there may be times when your child needs extra steroids.
- Avoid giving your child grapefruit and grapefruit juice.
- Talk with the doctor before your child gets any vaccines. Use of some vaccines with this drug may either raise the chance of very bad infection or make the vaccine not work as well.
- Tell the doctor if your child has missed a dose or recently stopped this drug and feels very tired, weak, or shaky, or has a fast heartbeat, confusion, sweating, or dizziness.

- A type of cancer (Kaposi's sarcoma) has happened in people taking drugs like this one for a long time. Talk with the doctor.
- This drug may affect growth in children and teens in some cases. They may need regular growth checks. Talk with the doctor.

If your child is pregnant or breast-feeding a baby:

- This drug may cause harm to the unborn baby if your child takes it during pregnancy. If your child is pregnant or gets pregnant while taking this drug, call the doctor right away.
- Tell the doctor if your child is breast-feeding a baby. You will need to talk about any risks to the baby.

All products except oral suspension:

- If your child has been taking this drug for many weeks, talk with your child's doctor before stopping. You may want to slowly stop this drug.
- Long-term use may raise the chance of cataracts, glaucoma, or weak bones (osteoporosis). Talk with your child's doctor.

What are some side effects that I need to call my child's doctor about right away?

WARNING/CAUTION: Even though it may be rare, some people may have very bad and sometimes deadly side effects when taking a drug. Tell your child's doctor or get medical help right away if your child has any of the following signs or symptoms that may be related to a very bad side effect:

All products:

- Signs of an allergic reaction, like rash; hives; itching; red, swollen, blistered, or peeling skin with or without fever; wheezing; tightness in the chest or throat; trouble breathing, swallowing, or talking; unusual hoarseness; or swelling of the mouth, face, lips, tongue, or throat.
- Signs of high blood sugar like confusion, feeling sleepy, unusual thirst or hunger, passing urine more often, flushing, fast breathing, or breath that

smells like fruit.

- Signs of infection like fever, chills, very bad sore throat, ear or sinus pain, cough, more sputum or change in color of sputum, pain with passing urine, mouth sores, or wound that will not heal.
- Signs of high blood pressure like very bad headache or dizziness, passing out, or change in eyesight.
- Signs of a weak adrenal gland like a severe upset stomach or throwing up, severe dizziness or passing out, muscle weakness, feeling very tired, mood changes, decreased appetite, or weight loss.
- Signs of Cushing's syndrome like weight gain in the upper back or belly, moon face, severe headache, or slow healing.
- Skin changes (pimples, stretch marks, slow healing, hair growth).
- Purple, red, blue, brown, or black bumps or patches on the skin or in the mouth.

Oral suspension:

- Redness or white patches in mouth or throat.
- Very bad mouth pain or irritation.
- Loss of taste.
- New or worse throat pain, heartburn, or trouble swallowing.
- Chest pain.
- Severe stomach pain, cramps, or diarrhea.

All other products:

- Any unexplained bruising or bleeding.
- Black, tarry, or bloody stools.
- Throwing up blood or throw up that looks like coffee grounds.
- Swelling in the arms or legs.
- Shortness of breath.

- Bone pain.
- Change in eyesight.

What are some other side effects of this drug?

All drugs may cause side effects. However, many people have no side effects or only have minor side effects. Call your child's doctor or get medical help if any of these side effects or any other side effects bother your child or do not go away:

Oral suspension:

- Headache.
- Signs of a common cold.

All other products:

- Headache.
- Signs of a common cold.
- Constipation, diarrhea, stomach pain, upset stomach, or throwing up.
- Heartburn.
- Gas.
- Feeling dizzy, tired, or weak.
- Back pain.
- Joint pain.

These are not all of the side effects that may occur. If you have questions about side effects, call your child's doctor. Call your child's doctor for medical advice about side effects.

You may report side effects to your national health agency.

How is this drug best given?

Give this drug as ordered by your child's doctor. Read all information given to you. Follow all instructions closely.

Tablets and capsules:

- Give in the morning if giving once a day.
- Give this drug with or without food.
- Keep giving this drug to your child as you have been told by your child's doctor or other health care provider, even if your child feels well.

Extended-release tablets:

- Have your child swallow whole with water. Do not let your child chew, break, or crush.

Delayed-release and extended-release capsules:

- Have your child swallow whole. Do not let your child chew or crush.
- Some products may be opened and sprinkled on a spoonful of applesauce. Some products must be swallowed whole. Check with your pharmacist to see if you can open this product.

Oral suspension:

- Do not give, or mix, with food or liquid. Do not let your child drink or eat for at least 30 minutes after taking this drug.
- Shake the packet for at least 10 seconds before opening. Squeeze the packet from the bottom to the top directly into the mouth. Repeat 2 to 3 times until the packet is empty. Have your child swallow all the drug. After 30 minutes, have your child rinse the mouth and spit without swallowing.
- Keep giving this drug to your child as you have been told by your child's doctor or other health care provider, even if your child feels well.

What do I do if my child misses a dose?

- Give a missed dose as soon as you think about it.
- If it is close to the time for your child's next dose, skip the missed dose and go back to your child's normal time.
- Do not give 2 doses at the same time or extra doses.

How do I store and/or throw out this drug?

Oral suspension:

- Store this drug in the refrigerator or at room temperature up to 86°F (30°C). Do not freeze.

All other products:

- Store at room temperature protected from light. Store in a dry place. Do not store in a bathroom.
- Keep lid tightly closed.

All products:

- Keep all drugs in a safe place. Keep all drugs out of the reach of children and pets.
- Throw away unused or expired drugs. Do not flush down a toilet or pour down a drain unless you are told to do so. Check with your pharmacist if you have questions about the best way to throw out drugs. There may be drug take-back programs in your area.

General drug facts

- If your child's symptoms or health problems do not get better or if they become worse, call your child's doctor.
- Do not share your child's drug with others and do not give anyone else's drug to your child.
- Some drugs may have another patient information leaflet. If you have any

questions about this drug, please talk with your doctor, nurse, pharmacist, or other health care provider.

- If you think there has been an overdose, call your poison control center or get medical care right away. Be ready to tell or show what was taken, how much, and when it happened.
