Mineral Oil

This information from Lexicomp® explains what you need to know about this medication, including what it's used for, how to take it, its side effects, and when to call your healthcare provider.

Brand Names: US

Fleet Oil [OTC]; FT Mineral Oil [OTC]; GoodSense Mineral Oil [OTC]

What is this drug used for?

- It is used to treat constipation.
- It is used to clean out the GI (gastrointestinal) tract.

What do I need to tell the doctor BEFORE my child takes this drug?

All products:

• If your child is allergic to this drug; any part of this drug; or any other drugs, foods, or substances. Tell the doctor about the allergy and what signs your child had

• If your child has any of these health problems: Bowel

Mineral Oil 1/10 block, belly pain, upset stomach, rectal bleeding, throwing up, or change in bowel habits lasting longer than 2 weeks.

If your child is pregnant:

• If your child is pregnant or may be pregnant. Some forms of this drug are not for use during pregnancy.

All oral products:

• If your child has trouble swallowing or is not able to stand or sit up.

This is not a list of all drugs or health problems that interact with this drug.

Tell the doctor and pharmacist about all of your child's drugs (prescription or OTC, natural products, vitamins) and health problems. You must check to make sure that it is safe to give this drug with all of your child's other drugs and health problems. Do not start, stop, or change the dose of any drug your child takes without checking with the doctor.

What are some things I need to know or do while my child takes this drug?

Mineral Oil 2/10

All products:

- Tell all of your child's health care providers that your child is taking this drug. This includes your child's doctors, nurses, pharmacists, and dentists.
- Do not give this drug for more than 1 week unless told to do so by your child's doctor.
- Do not give other laxatives or stool softeners unless told to do so by your child's doctor.
- If your child has rectal bleeding or does not have a bowel movement after using this drug, talk with your child's doctor.

If your child is breast-feeding a baby:

• Tell the doctor if your child is breast-feeding a baby. You will need to talk about any risks to the baby.

All oral products:

- This drug prevents many other drugs taken by mouth from getting into the body. If your child takes other drugs by mouth, give them at least 2 hours before or 2 hours after this drug. If you are not able to do this, talk with your child's doctor.
- Do not give this drug to a child younger than 6 years of age.

Mineral Oil 3/10

Rectal enema:

- If this drug is taken by mouth, get medical help or call a poison control center right away.
- Different brands of this drug may be for use in different ages of children. Talk with the doctor before giving this drug to a child.

What are some side effects that I need to call my child's doctor about right away?

WARNING/CAUTION: Even though it may be rare, some people may have very bad and sometimes deadly side effects when taking a drug. Tell your child's doctor or get medical help right away if your child has any of the following signs or symptoms that may be related to a very bad side effect:

- Signs of an allergic reaction, like rash; hives; itching; red, swollen, blistered, or peeling skin with or without fever; wheezing; tightness in the chest or throat; trouble breathing, swallowing, or talking; unusual hoarseness; or swelling of the mouth, face, lips, tongue, or throat.
- Very bad dizziness or passing out.
- Bleeding from rectum or rectal pain.

What are some other side effects of this drug?

All drugs may cause side effects. However, many people have no side effects or only have minor side effects. Call your child's doctor or get medical help if any of these side effects or any other side effects bother your child or do not go away:

- Stomach pain or cramps.
- Bloating.
- Gas.
- Diarrhea, upset stomach, or throwing up.

These are not all of the side effects that may occur. If you have questions about side effects, call your child's doctor. Call your child's doctor for medical advice about side effects.

You may report side effects to your national health agency.

How is this drug best given?

Give this drug as ordered by your child's doctor. Read all information given to you. Follow all instructions closely.

Mineral Oil 5/10

All oral products:

- Give this drug in the evening, unless your doctor tells you otherwise.
- Give on an empty stomach.
- Measure liquid doses carefully. Use the measuring device that comes with this drug. If there is none, ask the pharmacist for a device to measure this drug.

Oral emulsion:

• Shake well before use.

Rectal enema:

Give enema rectally.

What do I do if my child misses a dose?

- If your child takes this drug on a regular basis, give a missed dose as soon as you think about it.
- If it is close to the time for your next dose, skip the missed dose and go back to your normal time.
- Do not give 2 doses at the same time or extra doses.
- Many times this drug is given on an as needed basis.
 Do not give to your child more often than told by the doctor.

Mineral Oil 6/10

How do I store and/or throw out this drug? All products:

- Store at room temperature.
- Keep all drugs in a safe place. Keep all drugs out of the reach of children and pets.
- Throw away unused or expired drugs. Do not flush down a toilet or pour down a drain unless you are told to do so. Check with your pharmacist if you have questions about the best way to throw out drugs.
 There may be drug take-back programs in your area.

All oral products:

- Protect from light.
- Keep lid tightly closed.

General drug facts

- If your child's symptoms or health problems do not get better or if they become worse, call your child's doctor.
- Do not share your child's drug with others and do not give anyone else's drug to your child.
- Some drugs may have another patient information leaflet. If you have any questions about this drug, please talk with your child's doctor, nurse,

- pharmacist, or other health care provider.
- If you think there has been an overdose, call your poison control center or get medical care right away.
 Be ready to tell or show what was taken, how much, and when it happened.
