# Phenol

This information from Lexicomp® explains what you need to know about this medication, including what it's used for, how to take it, its side effects, and when to call your healthcare provider.

### **Brand Names: US**

Chloraseptic [OTC] [DSC]; GoodSense Sore Throat Spray [OTC]; Oralseptic [OTC]; Phenaseptic [OTC]; Phenol EZ Swabs [OTC]; Sore Throat Spray [OTC]; Triaminic Sore Throat [OTC]; Ulcerease [OTC] [DSC]

### **What is this drug used for?**

#### **All oral products:**

- It is used to treat a sore throat, sore mouth, or mouth irritation.

#### **Skin solution:**

- It is used to prevent skin infections.

## **What do I need to tell the doctor BEFORE my child takes this drug?**

### **All products:**

- If your child is allergic to this drug; any part of this drug; or any other drugs, foods, or substances. Tell the doctor about the allergy and what signs your child had.

### **Skin solution:**

- If a large area needs to be treated.
- If your child has an animal bite, a deep puncture wound, or a very bad burn or cut.

This is not a list of all drugs or health problems that interact with this drug.

Tell the doctor and pharmacist about all of your child's drugs (prescription or OTC, natural products, vitamins) and health problems. You must check to make sure that it is safe to give this drug with all of your child's other drugs and health problems. Do not start, stop, or change the dose of any drug your child takes without checking with the doctor.

## **What are some things I need to know or do while my child takes this drug?**

### **All products:**

- Tell all of your child's health care providers that your child is taking this drug. This includes your child's doctors, nurses, pharmacists, and dentists.
- Do not give this drug to your child for longer than you were told by the doctor.

### **If your child is pregnant or breast-feeding a baby:**

- Talk with the doctor if your child is pregnant, becomes pregnant, or is breast-feeding a baby. You will need to talk about the benefits and risks to your child and the baby.

### **Skin solution:**

- This drug may stain fingernails, hair, and skin.
- Protect clothing and fabrics from staining.

## **What are some side effects that I need to call my child's doctor about right away?**

**WARNING/CAUTION:** Even though it may be rare, some people may have very bad and sometimes deadly side effects when taking a drug. Tell your child's doctor or get medical help right away if your child has any of the following signs or symptoms that may be related to a

very bad side effect:

- Signs of an allergic reaction, like rash; hives; itching; red, swollen, blistered, or peeling skin with or without fever; wheezing; tightness in the chest or throat; trouble breathing, swallowing, or talking; unusual hoarseness; or swelling of the mouth, face, lips, tongue, or throat.
- Severe irritation where this drug was used.

### **What are some other side effects of this drug?**

All drugs may cause side effects. However, many people have no side effects or only have minor side effects. Call your child's doctor or get medical help if any of these side effects or any other side effects bother your child or do not go away:

#### **All oral products:**

- Mouth tingling.

#### **Skin solution:**

- Skin irritation.

These are not all of the side effects that may occur. If you have questions about side effects, call your child's doctor. Call your child's doctor for medical advice about side effects.

You may report side effects to your national health agency.

## **How is this drug best given?**

Give this drug as ordered by your child's doctor. Read all information given to you. Follow all instructions closely.

### **All oral products:**

- Some of these drugs need to be shaken before use. Be sure you know if this product needs to be shaken before using it.
- Do not let your child swallow this drug.

### **Oral rinse:**

- Have your child swish in mouth for 15 seconds and then spit out.

### **Oral spray:**

- Spray affected part of the mouth.
- Wait 15 seconds and then have your child spit out.

### **Skin solution:**

- Do not give by mouth. Use on your child's skin only. Keep out of your child's mouth, nose, and eyes (may

burn).

- Wash your hands before and after use.
- Clean affected part before use. Make sure to dry well.
- Put a thin layer on the affected part and rub in gently.
- Do not use coverings (bandages, dressings) unless told to do so by the doctor.

### **What do I do if my child misses a dose?**

- If your child uses this drug on a regular basis, give a missed dose as soon as you think about it.
- If it is close to the time for your child's next dose, skip the missed dose and go back to your child's normal time.
- Do not give 2 doses at the same time or extra doses.
- Many times this drug is given on an as needed basis. Do not give to your child more often than told by the doctor.

### **How do I store and/or throw out this drug?**

- Store at room temperature.
- Keep all drugs in a safe place. Keep all drugs out of the reach of children and pets.
- Throw away unused or expired drugs. Do not flush down a toilet or pour down a drain unless you are told

to do so. Check with your pharmacist if you have questions about the best way to throw out drugs. There may be drug take-back programs in your area.

## **General drug facts**

- If your child's symptoms or health problems do not get better or if they become worse, call your child's doctor.
- Do not share your child's drug with others and do not give anyone else's drug to your child.
- Some drugs may have another patient information leaflet. If you have any questions about this drug, please talk with your child's doctor, nurse, pharmacist, or other health care provider.
- If you think there has been an overdose, call your poison control center or get medical care right away. Be ready to tell or show what was taken, how much, and when it happened.
