# Vitamin A

This information from Lexicomp® explains what you need to know about this medication, including what it's used for, how to take it, its side effects, and when to call your healthcare provider.

#### **Brand Names: US**

A-25 [OTC]; Aquasol A; Gordons-Vite A [OTC]; True Vitamin A [OTC]; Vitamin A Fish [OTC]

# What is this drug used for? All oral products and injection:

• It is used to treat or prevent vitamin A deficiency.

#### All skin products:

It is used to treat some skin problems.

# What do I need to tell my doctor BEFORE I take this drug?

#### **All products:**

 If you are allergic to this drug; any part of this drug; or any other drugs, foods, or substances. Tell your doctor about the allergy and what signs you had.

#### All oral products and injection:

• If you have too much vitamin A in the blood.

This is not a list of all drugs or health problems that interact with this drug.

Tell your doctor and pharmacist about all of your drugs (prescription or OTC, natural products, vitamins) and health problems. You must check to make sure that it is safe for you to take this drug with all of your drugs and health problems. Do not start, stop, or change the dose of any drug without checking with your doctor.

# What are some things I need to know or do while I take this drug?

- Tell all of your health care providers that you take this drug. This includes your doctors, nurses, pharmacists, and dentists.
- Tell your doctor if you are pregnant, plan on getting pregnant, or are breast-feeding. You will need to talk about the benefits and risks to you and the baby.
- Do not take more vitamin A than what your doctor told you to take.

  Taking too much vitamin A during pregnancy may cause birth defects. If
  you have questions, talk with your doctor.

# What are some side effects that I need to call my doctor about right away?

**WARNING/CAUTION:** Even though it may be rare, some people may have very bad and sometimes deadly side effects when taking a drug. Tell your doctor or get medical help right away if you have any of the following signs or symptoms that may be related to a very bad side effect:

• Signs of an allergic reaction, like rash; hives; itching; red, swollen, blistered, or peeling skin with or without fever; wheezing; tightness in the chest or throat; trouble breathing, swallowing, or talking; unusual hoarseness; or swelling of the mouth, face, lips, tongue, or throat.

### What are some other side effects of this drug?

All drugs may cause side effects. However, many people have no side effects or only have minor side effects. Call your doctor or get medical help if you have any side effects that bother you or do not go away.

## How is this drug best taken?

Use this drug as ordered by your doctor. Read all information given to you. Follow all instructions closely.

#### All oral products:

- Some brands of this drug are to be taken with food. Some brands may be taken with or without food. Ask your pharmacist if you need to take your brand with food.
- Keep taking this drug as you have been told by your doctor or other health care provider, even if you feel well.

#### All skin products:

- Do not take this drug by mouth. Use on your skin only. Keep out of your mouth, nose, ears, and eyes (may burn).
- Clean affected part before use. Make sure to dry well.
- Wash your hands before and after use. If your hand is the treated area, do not wash your hand after use.
- Put a thin layer on the affected part and rub in gently.

### Injection:

This drug is given as a shot into a muscle only. Very bad and sometimes
deadly effects have happened when this drug was given into a vein or
artery. Talk with the doctor.

# What do I do if I miss a dose? All oral products:

- Take a missed dose as soon as you think about it.
- If it is close to the time for your next dose, skip the missed dose and go back to your normal time.
- Do not take 2 doses at the same time or extra doses.

#### All skin products:

- Put on a missed dose as soon as you think about it.
- If it is close to the time for your next dose, skip the missed dose and go back to your normal time.
- Do not put on 2 doses at the same time or extra doses.

#### Injection:

• Call your doctor to find out what to do.

# How do I store and/or throw out this drug? Injection:

• If you need to store this drug at home, talk with your doctor, nurse, or pharmacist about how to store it.

### All other products:

• Store at room temperature in a dry place. Do not store in a bathroom.

#### All products:

- Keep all drugs in a safe place. Keep all drugs out of the reach of children and pets.
- Throw away unused or expired drugs. Do not flush down a toilet or pour down a drain unless you are told to do so. Check with your pharmacist if you have guestions about the best way to throw out drugs. There may be

drug take-back programs in your area.

### **General drug facts**

- If your symptoms or health problems do not get better or if they become worse, call your doctor.
- Do not share your drugs with others and do not take anyone else's drugs.
