The Code of Conduct is not intended to replace existing policies and procedures, but rather is to be used in combination with them.

Conflict of Interest

This policy requires our staff to report their professional and financial interests with outside companies and vendors so that these relationships can be reviewed to identify possible conflicts of interest.

Effort Reporting

Effort reporting is a federally mandated process to ensure that research funds charged to government-sponsored projects represent real work performed on the project and are not arbitrarily charged based on budget estimates or fund balances. More

Export Control Policy and Procedures

In order to ensure compliance with US export control laws and regulations, Research and Technology Management (RTM) has initiated an export control compliance policy and program for MSK. United States export control laws are a body of several laws administered by various federal agencies. All US persons and entities, including research institutions like MSK, are subject to and must comply with these laws. Export controls affect a number of functions at MSK; therefore, RTM has developed a policy to help ensure the Center and its employees comply with these federal laws. Export control laws prohibit unlicensed international shipments of certain items (including the carrying of controlled items while travelling internationally), transmissions of certain data overseas, and transfers of certain information to foreign nationals in the US.

Memorial Sloan Kettering's NIH Public Access Policy

Investigators who are funded by the National Institutes of Health need to submit an electronic version of their final, peer-reviewed manuscripts to the National Library of Medicine's PubMed Central upon acceptance of the manuscript for publication. The NIH requires that these manuscripts be made publicly available no later than 12 months after the official date of publication.

The "Sharing Model Organisms for Biomedical Research" policy mandated by the National Institutes of Health requires investigators to include a plan for organism sharing as a component of certain grant applications.

Memorial Sloan Kettering faculty, research staff, trainees, and students are obligated to retain research data in appropriate form, archive this information for a certain length of time, and make it available for collaborative research and review.
