# Aprepitant

This information from Lexicomp® explains what you need to know about this medication, including what it's used for, how to take it, its side effects, and when to call your healthcare provider.

### **Brand Names: US**

Aponvie; Cinvanti; Emend; Emend Tri-Pack

### **Brand Names: Canada**

Emend; Emend Tri-Pack

### **What is this drug used for?**

- It is used to prevent upset stomach and throwing up.

### **What do I need to tell my doctor BEFORE I take this drug?**

- If you are allergic to this drug; any part of this drug; or any other drugs, foods, or substances. Tell your doctor about the allergy and what signs you had.
- If you take any drugs (prescription or OTC, natural products, vitamins) that must not be taken with this drug, like certain drugs that are used for HIV,

infections, or seizures. There are many drugs that must not be taken with this drug.

- If you are pregnant or may be pregnant. Some forms of this drug are not for use during pregnancy.

This is not a list of all drugs or health problems that interact with this drug.

Tell your doctor and pharmacist about all of your drugs (prescription or OTC, natural products, vitamins) and health problems. You must check to make sure that it is safe for you to take this drug with all of your drugs and health problems. Do not start, stop, or change the dose of any drug without checking with your doctor.

## **What are some things I need to know or do while I take this drug?**

### **All products:**

- Tell all of your health care providers that you take this drug. This includes your doctors, nurses, pharmacists, and dentists.
- Avoid grapefruit and grapefruit juice.
- Birth control pills and other hormone-based birth control may not work as well to prevent pregnancy. Use some other kind of birth control also, like a condom, when taking this drug and for 1 month after

the last dose.

- Tell your doctor if you are breast-feeding. You will need to talk about any risks to your baby.

## **Injection:**

- Allergic reactions have happened during or soon after infusion of this drug. You will be watched closely while getting this drug and for some time after your dose. Tell your doctor or other health care provider right away if you have dizziness or passing out, fast or abnormal heartbeat, flushing or redness of the face or skin, itching, shortness of breath, swelling of the eyes, trouble swallowing, or wheezing.
- This drug may cause harm to the unborn baby if you take it while you are pregnant. If you are pregnant or you get pregnant while taking this drug, call your doctor right away.

## **What are some side effects that I need to call my doctor about right away?**

**WARNING/CAUTION:** Even though it may be rare, some people may have very bad and sometimes deadly side effects when taking a drug. Tell your doctor or get medical help right away if you have any of the following signs or symptoms that may be related to a very bad side effect:

## **All products:**

- Signs of an allergic reaction, like rash; hives; itching; red, swollen, blistered, or peeling skin with or without fever; wheezing; tightness in the chest or throat; trouble breathing, swallowing, or talking; unusual hoarseness; or swelling of the mouth, face, lips, tongue, or throat.
- Signs of a very bad skin reaction (Stevens-Johnson syndrome/toxic epidermal necrolysis) like red, swollen, blistered, or peeling skin (with or without fever); red or irritated eyes; or sores in the mouth, throat, nose, or eyes.
- Signs of dehydration like dry skin, mouth, or eyes; thirst; fast heartbeat; dizziness; fast breathing; or confusion.
- Signs of infection like fever, chills, very bad sore throat, ear or sinus pain, cough, more sputum or change in color of sputum, pain with passing urine, mouth sores, or wound that will not heal.

## **Injection:**

- Irritation where this drug is given.

## **What are some other side effects of this drug?**

All drugs may cause side effects. However, many people have no side effects or only have minor side effects. Call your doctor or get medical help if any of these side effects or any other side effects bother you or do not go away:

- Feeling dizzy, tired, or weak.
- Diarrhea or constipation.
- Decreased appetite.
- Stomach pain or heartburn.
- Hiccups.
- Headache.
- Burping.

These are not all of the side effects that may occur. If you have questions about side effects, call your doctor. Call your doctor for medical advice about side effects.

## **How is this drug best taken?**

Use this drug as ordered by your doctor. Read all information given to you. Follow all instructions closely.

### **All oral products:**

- This drug may be taken with or without food. Be sure to follow the doctor's instructions with regard to food.

### **Capsules:**

- Swallow whole. Do not chew, open, or crush.

### **Liquid (suspension):**

- This drug will be mixed by a doctor or pharmacist.
- When ready to use, place the pre-filled device in the mouth on the inner cheek. Squirt the drug out slowly into the mouth.

### **Injection:**

- It is given as an infusion into a vein over a period of time.

## **What do I do if I miss a dose?**

- Call your doctor to find out what to do.

## **How do I store and/or throw out this drug?**

### **Capsules:**

- Store at room temperature in a dry place. Do not store in a bathroom.

### **Liquid (suspension):**

- Store in a refrigerator. Do not freeze.
- Use this drug within 2 days of getting it from the doctor. Throw away any doses left after 2 days.
- When ready to use, this drug may be stored at room temperature for up to 3 hours.

### **Injection:**

- If you need to store this drug at home, talk with your doctor, nurse, or pharmacist about how to store it.

### **All products:**

- Keep all drugs in a safe place. Keep all drugs out of the reach of children and pets.
- Throw away unused or expired drugs. Do not flush down a toilet or pour down a drain unless you are told to do so. Check with your pharmacist if you have questions about the best way to throw out drugs. There may be drug take-back programs in your area.

## **General drug facts**

- If your symptoms or health problems do not get better or if they become worse, call your doctor.
- Do not share your drugs with others and do not take anyone else's drugs.
- Some drugs may have another patient information leaflet. If you have any questions about this drug, please talk with your doctor, nurse, pharmacist, or other health care provider.
- Some drugs may have another patient information leaflet. Check with your pharmacist. If you have any questions about this drug, please talk with your doctor, nurse, pharmacist, or other health care provider.
- If you think there has been an overdose, call your poison control center or get medical care right away. Be ready to tell or show what was taken, how much, and when it happened.
