# PATIENT & CAREGIVER EDUCATION Diethylene Triamine Penta-Acetic Acid

This information from Lexicomp<sup>®</sup> explains what you need to know about this medication, including what it's used for, how to take it, its side effects, and when to call your healthcare provider.

### What is this drug used for?

• It is used to treat some kinds of radiation poisoning.

# What do I need to tell the doctor BEFORE my child takes this drug?

• If your child is allergic to this drug; any part of this drug; or any other drugs, foods, or substances. Tell the doctor about the allergy and what signs your child had.

## If your child is breast-feeding a baby:

• Be sure your child does not breast-feed a baby while taking this drug.

This drug may interact with other drugs or health

problems.

Tell the doctor and pharmacist about all of your child's drugs (prescription or OTC, natural products, vitamins) and health problems. You must check to make sure that it is safe to give this drug with all of your child's other drugs and health problems. Do not start, stop, or change the dose of any drug your child takes without checking with the doctor.

# What are some things I need to know or do while my child takes this drug?

- Tell all of your child's health care providers that your child is taking this drug. This includes your child's doctors, nurses, pharmacists, and dentists.
- Have blood work checked as you have been told by the doctor. Talk with the doctor.
- Clean up any spilled urine, feces, or blood right away. Avoid touching.
- Have your child pass urine often. Your child needs to empty the bladder often. Having your child drink lots of liquids will help.
- Have your child use the toilet instead of a urinal.
- Have your child use the same toilet each time when using the bathroom at home. Have your child sit down

on the toilet to urinate to keep urine from splashing or spraying. Flush the toilet a few times after each use .

- Wash exposed clothing, bedding, and bath towels alone.
- If your child coughs, clean up mucus right away. Avoid touching. Do not swallow mucus. Talk to the doctor if your child is coughing.

# If your child is pregnant:

• Tell the doctor if your child is pregnant or becomes pregnant. You will need to talk about the benefits and risks of your child using this drug while pregnant.

# What are some side effects that I need to call my child's doctor about right away?

WARNING/CAUTION: Even though it may be rare, some people may have very bad and sometimes deadly side effects when taking a drug. Tell your child's doctor or get medical help right away if your child has any of the following signs or symptoms that may be related to a very bad side effect:

• Signs of an allergic reaction, like rash; hives; itching; red, swollen, blistered, or peeling skin with or without fever; wheezing; tightness in the chest or throat; trouble breathing, swallowing, or talking; unusual hoarseness; or swelling of the mouth, face, lips, tongue, or throat.

• Chest pain.

# What are some other side effects of this drug?

All drugs may cause side effects. However, many people have no side effects or only have minor side effects. Call your child's doctor or get medical help if any of these side effects or any other side effects bother your child or do not go away:

- Dizziness or headache.
- Metallic taste.
- Upset stomach.
- Diarrhea.
- Irritation where the shot is given.

These are not all of the side effects that may occur. If you have questions about side effects, call your child's doctor. Call your child's doctor for medical advice about side effects.

You may report side effects to your national health agency.

# How is this drug best given?

Give this drug as ordered by your child's doctor. Read all information given to you. Follow all instructions closely.

- This drug will be given to your child by a doctor.
- Have your child drink lots of noncaffeine liquids unless told to drink less liquid by your child's doctor.

#### What do I do if my child misses a dose?

• Call your child's doctor to find out what to do.

## How do I store and/or throw out this drug?

• If you need to store this drug at home, talk with your child's doctor, nurse, or pharmacist about how to store it.

### **General drug facts**

- If your child's symptoms or health problems do not get better or if they become worse, call your child's doctor.
- Do not share your child's drug with others and do not give anyone else's drug to your child.
- Keep all drugs in a safe place. Keep all drugs out of the reach of children and pets.
- Throw away unused or expired drugs. Do not flush

down a toilet or pour down a drain unless you are told to do so. Check with your pharmacist if you have questions about the best way to throw out drugs. There may be drug take-back programs in your area.

- Some drugs may have another patient information leaflet. If you have any questions about this drug, please talk with your doctor, nurse, pharmacist, or other health care provider.
- If you think there has been an overdose, call your poison control center or get medical care right away. Be ready to tell or show what was taken, how much, and when it happened.
