COURSE OBJECTIVES

2. Identify barriers to adequate pain relief for patients across the life span.
3. Identify common symptoms associated with End of Life processes for patients with cancer across the life span.
4. Identify dimensions of culture and the influence of culture on palliative care for patients across the life span.
5. Describe the role of the nurse in providing quality palliative care for children and families.
6. Define the importance of ongoing communication with the inter-disciplinary team, patients and family throughout and end of life process.
7. Define loss, mourning, grief and bereavement
8. Discuss ethical issues and dilemmas that may arise in end-of-life care
9. List steps in the assessment of an imminently dying cancer patient and five physical signs and symptoms of the dying process and three signs of death.
